# Section 5. Membership Application Guidelines 入會申請守則

## 1. Corporate Designer Member 公司會員

(i) Companies under the laws of Hong Kong or any other jurisdictions running jewellery design business shall be eligible for Corporate Designer Membership.

凡香港特區政府計冊之珠寶設計業務的公司,均可申請為公司會員。

(ii) Corporate Designer Member can assign up to TWO (2) representatives to enjoy all benefits and activities provided by the Association. Any change of the representatives must be informed within 1 month by written notification to the Association.

公司會員可以擁有兩位**(2)**代表享有協會之服務利益或活動。如果有關公司會員代表有變,公司會員有責任在變動後一個月內以書面通知協會。

(iii) Attend the Annual General Meeting with ONE (1) right to propose and vote. Primary Corporate Designer Member shall be the representative who possesses the right to vote unless presented with a written notification to the Association prior to the Annual General meeting.

出席周年全體會員大會,公司會員擁有一票會上動議權或表決權。除非公司會員以書面通知,否則第一公司會員為公司會員唯一動議權或表決權的代表。

- (iv) All Corporate Designer Members must pay an entry fee of HK\$20,000. 凡公司會員必須繳付入會費港幣 20,000 元。
- (v) All Corporate Designer Members shall abide by the regulations of the Association. 公司會員必須遵守本協會規章。
- (vi) All Corporate Designer Members shall notify in writing one month prior to their membership resignation.
- 公司會員必須在退出會籍前一個月以書面通知協會。
  (vii) The Association reserves the right to terminate the membership of a Corporate Designer Member should the Member violates the regulations of the Association or found to be damaging to the Association.

若發現公司會員有違反法律及本會守則的行為,本會有權立即取消會員的會籍及停止一切會員權益。

#### 2. Individual Designer Member 設計師會員

(i) Persons of any nationality who are in the jewellery design business shall be eligible for Individual Designer Membership.

凡任何國籍人士從事珠寶設計業務均可申請為設計師會員。

- (ii) Individual Designer Member can enjoy all benefits and activities provided by the Association. 設計師會員可以享有協會之服務利益或活動。
- (iii) Attend the Annual General Meeting with ONE (1) right to propose and vote. .出席周年全體會員大會,設計師會員擁有一票會上動議權或表決權。
- (iv) All Individual Designer Members must pay an entry fee of HK\$3,300. 凡設計師會員必須繳付入會費港幣 3,300 元。
- (v) All Individual Designer Member shall abide by the regulations of the Association. 設計師會員必須遵守本協會規章。
- (vi) All Individual Designer Member shall notify in writing one month prior to their membership resignation. 設計師會員必須在退出會籍前一個月以書面通知協會。
- (vii) The Association reserves the right to terminate the membership of an Individual Designer Member should the Member violates the regulations of the Association or found to be damaging to the Association.

若發現設計師會員有違反法律及本會守則的行為,本會有權立即取消會員的會籍及停止一切會員權益。

## 3. Non-Designer Member 非設計師會員

- (i) Persons of any nationality who are in the businesses related to jewellery, and are interested in taking part in, advising or assisting the development of the jewellery design industry but not running or being part of jewellery design business shall be eligible for Non-Designer Member.
  - 凡任何國籍人士從事珠寶業務,如有興趣參與指導、咨詢及幫助珠寶設計行業之發展,但並不擁有珠寶設計業務,均可申請為非設計師會員。
- (ii) Non-Designer Member can enjoy most benefits and activities provided by the Association, except participating exhibition booths allocated for IJDA's Corporate Designer Members and Individual Designer Members.
  - 非設計師會員可以享有協會之大部分服務利益或活動,除了參與 IJDA 從珠寶展覽會分配給公司會員和 設計師會員的展覽攤位。
- (iii) Attend the Annual General Meeting but WITHOUT the right to propose and vote, and does not participate in the operations of the Association.
  - 出席周年全體會員大會但沒有動議權或表決權,也不能參與本協會的日常運作。
- (iv) All Non-Designer Members must pay an entry fee of HK5,000.

凡非設計師會員必須繳付入會費港幣 5,000 元。

- (v) All Non-Designer Members shall abide by the regulations of the Association. 非設計師會員必須遵守本協會規章。
- (vi) All Non-Designer Members shall notify in writing one month prior to their membership resignation. 非設計師會員必須在退出會籍前一個月以書面通知協會。
- (vii) The Association reserves the right to terminate the membership of a Non-Designer member should the member violates the regulations of the Association or found to be damaging to the Association. 若發現非設計師會員有違反法律及本會守則的行為,本會有權立即取消會員會籍及停止一切會員權益。
